This is my short story recognizing and giving praise to the Firefighter/EMTs, Firefighter/Paramedic and other unnamed individuals who assisted me.

At the end of the church service while attempting to stand I recognized something wrong and had difficulty standing. I was experiencing breathing issues and my vision was blurry. Attempting to breathe deep my wife recognized that my body was swaying and had me sit immediately. My body was profusely sweating and my breathing was not improving. After some time I went outdoors to sit where it was very cool and helped me cool down. The Concord Fire Department arrived and I was quickly surrounded by many who asking me questions regarding my symptoms. It became obvious they were trying to discover if I possibly had a heart attack, stroke or other health malady. They quickly and efficiently hooked me up to an EKG monitor and transported me to Concord Hospital, where I was then transferred into the care of Concord Hospital.

I am very thankful for those Firefighters/EMTs, Firefighter/Paramedics and others who treated me with excellent care and professionalism. I am disappointed that I just don't know the names of those who cared for me on that day but I am thankful

for each of them and their professional care I received and so this is a big thank you to each of them!
