RESOLUTION IN RECOGNITION OF THE SERVICES OF

Lieutenant Sean K. Ford

The City of Concord resolves as follows:

WHEREAS, Lieutenant Sean K. Ford has been a faithful and loyal employee of the City of Concord for over 21 years within its Police Department. Lieutenant Ford began his Concord Police Department career in 1998 as a Police Officer. He previously served as a Police Officer in the Town of Pittsfield and also as a part-time Police Officer for both the Town of Henniker and the Town of Weare; and

WHEREAS, Lieutenant Ford served in the Patrol Division until 2000 at which time he was selected to be assigned to the Criminal Investigations Division. Lieutenant Ford served with distinction as an Investigator until he was promoted to the rank of Sergeant in 2013 and served as a Supervisor in the Patrol Division. In November of 2014, Lt. Ford was assigned as the Supervisor of the Youth Services Unit and shortly thereafter was assigned as the Supervisor of the Criminal Investigations Unit; and

WHEREAS, In 2017, Lieutenant Ford was promoted to the rank of Lieutenant where he remained in the Criminal Investigations Division serving as the Division Commander. Lt. Ford served in this capacity until his retirement on November 30, 2019; and

WHEREAS, Lieutenant Ford received the NH Congressional Law Enforcement Award for Dedication and Professionalism in 2006, and also received the NH Chiefs of Police Law Enforcement Foundation Officer of the Year Award in 2009 as well as the Retail Merchants Association of NH Law Enforcement Partner of the Year Award that same year; and

WHEREAS, Lieutenant Ford was the recipient of the Concord Police Department Police Officer of the Year Award in 2013, and he has also received multiple Distinguished Unit Action Awards and Meritorious Service Awards over the course of his career. Additionally he has received numerous Letters of Commendation and letters of appreciation from members of the community; and

WHEREAS, Lieutenant Ford's dedication and loyalty to the Concord Police Department and City of Concord are without question; and

WHEREAS, Lieutenant Sean K. Ford's work ethic, determination, energy and dedication have time and time again benefited the City of Concord and the Concord Police Department, whether it was through his investigations of criminal activity, training and mentoring of fellow police officers, or through his leadership as a Police Sergeant and Lieutenant.
