**RESOLUTION** ACCEPT AND APPROPRIATE THE SUM OF THIRTEEN THOUSAND, FIVE HUNDRED DOLLARS (\$13,500) IN GRANT FUNDS FROM THE NEW HAMPSHIRE HIGHWAY SAFETY AGENCY, FUNDS DESIGNATED FOR THE PURCHASE OF MOBILE SCANNING AND PRINTING EQUIPMENT.

*The City of Concord resolves as follows:*

- WHEREAS,** the Concord Police Department has received notification from the New Hampshire Highway Safety Agency that we have been awarded a grant in the amount of thirteen thousand, five hundred dollars (\$13,500); and
- WHEREAS,** the Concord City Council approved Resolution #8906, adopted April 11, 2016, at their regular meeting authorizing the City Manager to apply for the above grant; and
- WHEREAS,** these funds have been designated by the New Hampshire Highway Safety Agency to be applied towards the purchase of mobile scanning and printing equipment to be installed in the Police Department's marked cruisers; and
- WHEREAS,** there is an in-kind match by the City in the amount of \$3,375 required for accepting these funds; and
- WHEREAS,** this in-kind match will be accounted for through Department expenses involved in the installation, maintenance, consumables, and training costs associated with the installation and use of this equipment; and
- WHEREAS,** this appropriation is for a purpose not included in the adopted budget, therefore section 37 of the City Charter requires a two-thirds vote of the City Council;

***NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:***
