## The City of Concord resolves as follows:

- WHEREAS, on February 8, 2021, the Terminal Building Study was presented to City Council and approval to move forward with the design and construction of a new Terminal Building (CIP #383) was granted; and
- WHEREAS. Resolution #9541 approved at the March 13, 2023 City Council meeting authorized the City Manager to apply for a grant for this purpose; and
- WHEREAS. project grant funding will be allocated as follows: \$365,754 (90%) Federal share, \$20,320 (5%) State share, and \$20,320 (5%) City share; and
- WHEREAS. a portion of the new terminal is allocated for private use (administration, car rental, tenant, and a small eatery), costs for which are non-eligible for FAA or State funding and total \$154,680; and
- WHEREAS, RSA 33:9 mandates that a two-thirds vote of all members of the City Council is required to pass a bond resolution; and
- WHEREAS, this appropriation is for a purpose for which funding was not included in the Fiscal Year 2024 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.

2)	Revenue to meet said appropriation shall be provided from the following sources:
	General Capital Project Fund
	Federal grant funds\$365,754
	State of New Hampshire grant funds\$20,320
	General Obligation Bonds and Notes\$175,000

3) In order to meet said expenditure the City Treasurer, with approval of the City Manager, is authorized to issue up to \$175,000 in bonds and notes of the City of Concord under RSA 162-K:8, Chapter 280 of the Acts of 2000 and/or RSA 33:9 of the Municipal Finance Act.

- 4) The discretion of the fixing of dates, maturities, rate of interest, form and other details of such bonds and notes (including whether such bonds or notes shall be issued on a tax exempt or taxable basis) and providing for the sale are hereby delegated to the City Treasurer.
- 5) The useful life of the project is expected to be in excess of twenty (20) years.
