The City of Concord resolves as follows:

WHEREAS, the City of Concord was eligible to apply and receive funding for updating the SWPPP; and

WHEREAS, Resolution #9369 approved at the April 12, 2021 City Council meeting authorized the City Manager to apply for a grant in the amount up to \$8,425; and

WHEREAS, the City’s grant application for this purpose has been accepted and project funding will be allocated as follows: \$7,650 (90%) Federal share, \$425 (5%) State share, and \$425 (5%) City share; and

WHEREAS, the Airport Advisory Committee recommends that the City Council approve this project; and

WHEREAS, this appropriation is for a purpose for which funding was not included in the Fiscal Year 2022 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:
