WHEREAS,	The Sound & Color Music and Arts Festival Committee is organizing a 2-
	day art and music festival taking place at venues and outdoor locations
	throughout downtown Concord, on October 18 and 19, 2024; and,

WHEREAS, the Committee's goal through the festival is to promote the removal of all barriers to arts access and the importance of the arts community to the region and beyond; and,

WHEREAS, the Committee requests permission from the City to install a semi-opaque vinyl photographic exhibit on the upper portion of the

windows of the Storrs St. Garage for a period of 1 year (September 2024 to August 2025), as the location is central to the "Hub" of the festival on Main

St. between Pleasant St. and the Food Co-op; and,

WHEREAS, the Committee also request permission to install battery powered LED

lights on the windows of the Storrs St. Garage for not more than one week

during the festival; and,

the Committee recently obtained the Parking Committee's recommendation WHEREAS,

to approve the installation of the vinyl art and lighting proposed by the

Committee; and,

WHEREAS, the Committee will be solely responsible for the costs, design, permitting,

installation, ownership, operation and maintenance of improvements

constructed on the City's property.

NOW, THERFORE, BE IT RESOLVED by the City Council of Concord that:

1) The City Manager is authorized to enter into a License Agreement concerning the design, permitting, installation, ownership, operation and maintenance of said improvements on the City's Storrs Street Garage Main Street stair tower.
