**The City of Concord ordains as follows:**

**SECTION I:** amending the CODE OF ORDINANCES; Title II, Traffic Code; Chapter 18, Parking, Article 18-1, Stopping, Standing, and Parking, Section 18-1-6, Parking Prohibited at All Times in Designated Places, by amending Schedule I to modify no parking areas on the following streets:

Pleasant St., south side	190' west of S. State St.	50' easterly	6:00 a.m. to 7:00 p.m. Weekdays
