be included in the City of Concord's Trail System; and

this trail will be part of the trail system that would connect Marjory Swope WHEREAS,

Park with other large open space parcels in West Concord, including Rossview

Farm and Carter Hill Orchard: and

WHEREAS, the continued improvement of the City's trail system is a recommendation

found in both the City of Concord Open Space Plan and the Master Plan

2030: and

WHEREAS, the Conservation Commission has prepared a Trail Agreement to formalize

> the inclusion of this trail into the City's Trail System and to outline the manner in which the trail shall be utilized, administered and maintained;

and

WHEREAS, an agreement with the City would allow Jane E. Raymond to benefit from

> the provisions of RSA 508:14, Landowner Limited Liability, which states "An owner, occupant, or lessee of land, including the state or any political subdivision, who without charge permits any person to use land for recreational purposes or as a spectator of recreational activity, shall not be liable for personal injury or property damage in the absence of

intentionally caused injury or damage."
