the Concord Police Department has played an integral role in the development of an Adverse Childhood Experience Response Team (ACERT) Program in the Concord area which is designed to serve and offer resources to children who have been exposed to violence; and

WHEREAS,

the Concord ACERT Program will be administered by funding in the amount of \$26,000 through the Granite United Way and managed in the Granite United Way grant project; and

WHEREAS,

the Concord Police Department desires to utilize this funding for reimbursement of overtime costs associated with the Department's participation in ACERT activities in assisting children exposed to violence; and

WHEREAS,

there is no financial match required for this program; and

WHEREAS.

this appropriation is for a purpose for which funds were not included in the Fiscal Year 2022 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.
