I am writing to express my opposition to a sidewalk fountain in front of our State Capitol.

My reasons are listed below:

• The area is too small for such a fountain. Even though the fountain will only take up the south section of the plaza, a bit away from the war memorial, a substantial spillover effect will be inevitable and constant.

A quick glance at some of these fountains across the country show them to be in larger plaza areas and/or on the edge of a park.

I accepted the invitation in a recent Monitor online comment to Google Salem, Oregon's supposedly similar fountain. That fountain is actually situated on many wide-open acres, a site almost the opposite of the cramped Concord site.

- This area has a war memorial and is a place of civic gatherings. I can just visualize the towels strewn across both sides of the arch. There most likely will be a clamor for the city to provide bathroom and other facilities on this small site.
- Following Susanne Meyer's recent excellent My Turn in the Concord Monitor, there was a comment that there were "two used hypodermic needles and three used condoms in the area around the memorial." There

is no logical connection here-a fountain would not make needles and condoms in the area less likely. In fact, these items could easily end up in and around the fountain.

 There is a potential risk of injury from children (or adults) slipping or running into each other as well as exposure to water-borne contaminants.

Since 2012, the Crown Center fountain in Kansas City, MO no longer allows people in the fountain for the above reasons.

- Regardless of the fact that this is most likely going to be a recirculation fountain, there will still be loss of water through evaporation and spillage.
- It has been estimated that the ongoing maintenance costs for this fountain would be \$ 4,000 to \$5,000 each year. I am not sure how this estimate was obtained, but initial estimates usually end up higher than what was originally quoted. And, undoubtedly that with each year of use, there will be additional costs for labor and replacement parts, making the annual maintenance costs rise.

In a March 1,2009 an article in the Salem Weekly (Oregon), a similar fountain's yearly maintenance expenses was calculated to be about \$6,000. It was pointed out in this article that the city of Salem would soon be paying approximately \$9,500 annually for maintenance due to labor and replacement parts (and that was in 2009).
