- **WHEREAS,** the City of Concord Wastewater Division desires to upgrade the three existing secondary clarifiers at the Hall Street Wastewater Treatment Facility to maintain treatment; and
- WHEREAS, the City of Concord submitted a preliminary application for funding the Secondary Clarifier Upgrade subproject (CIP #104), in an amount of up to \$3,800,000 from the New Hampshire Department of Environmental Services (NHDES); and
- **WHEREAS,** NHDES has offered the City of Concord an American Rescue Plan Act (ARPA) grant in an amount of up to 20% (\$760,000) of total eligible project costs for this project; and
- **WHEREAS,** in order to meet remaining project costs, the City wishes to secure general obligation bonds in the amount of \$3,040,000; and
- WHEREAS, this appropriation is for a purpose for which funds are not included in the Fiscal Year 2022 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council to approve this Resolution; and
- **WHEREAS,** RSA 33:9 mandates that a two-thirds vote of all members of the City Council is required to pass a bond resolution.

- 3) In order to meet said expenditure, the City Treasurer, with approval of the City Manager, is authorized to issue \$3,040,000 in bonds and notes of the City of Concord in accordance with RSA 33:9.
- 4) The discretion of the fixing of dates, maturities, rate of interest, form and other details of such bonds and notes (including whether such bonds or notes shall be issued on a tax exempt or taxable basis) and providing for the sale are hereby delegated to the City Treasurer.
- 5) The useful life of the project is expected to be in excess of twenty (20) years.
- 6) The following four statements are required under the NHDES rules for acceptance of funds:
 - A. The City Manager, or his designee, is hereby authorized to take such actions as may be necessary to apply to the NHDES for a grant through the ARPA for the purposes of the Secondary Clarifier Upgrade Project at the Hall Street Wastewater Treatment Facility;
 - B. In the event the City of Concord is awarded this grant, the City Council hereby accepts the grant;
 - C. The City Council authorizes raising, appropriating, and expending the sum of up to Three Million Eight Hundred Thousand Dollars (\$3,800,000) through the issuance of bonds and/or notes of the City of up to Three Million Forty Thousand Dollars (\$3,040,000) under the Municipal Finance Act and participation in the
