The City of Concord resolves as follows:

- WHEREAS, the Fiscal Year 2022 Capital Improvement Plan provided funding in the Hall Street Wastewater Treatment Plant Improvements project (CIP #104) and the Penacook Wastewater Treatment Plant Improvements subproject (CIP #466) for SCADA system upgrades; and
- **WHEREAS**, the SCADA system upgrade subprojects at both plants have a shortfall of funds due to the cost of the unexpected additional software licenses needed to provide continuation of dependable automatic emergency paging services; and
- WHEREAS, the Fiscal Year 2021 Scum Processing Equipment subproject (CIP #104) is now complete, leaving available funding in the amount of \$8,832.56 and the Fiscal Year 2021 Security Fence subproject (CIP #466) is also complete, leaving available funding in the amount of \$9,150. The savings from these projects is due to unused contingency funds; and
- **WHEREAS,** this repurposing of bond proceeds requires a two-thirds vote of the City Council under RSA 33:3-a, II.
