SUBJECT: September Fiscal Year-to-Date 2025 Financial Statements

The attached financial statements for the period ending September 30, 2024 represent 25% of the elapsed Fiscal Year 2025. The highlights of the City's financial status for this time period are presented by fund or groups of funds below. Comparisons are being made to the FY25 adopted budget and previous year FY24 same period results.

General Fund

Revenues:

- 1) 25% of the way through the Fiscal Year, revenue and expense lines are on track. Current trends are identified below and new trends that develop will be identified as early as possible.
- 2) Finance –
 - a. Motor Vehicle Registrations are \$93,400 ahead of FY24 and on target with budget at 24% YTD.
 - b. Investment income is \$50,200 ahead of FY24 and ahead of budget at 29%. With the recent interest rate cut by the federal reserve, I expect this revenue to start weakening.
- 3) Fire –
 - a. Ambulance Charges are ahead of budget at 27% and ahead of FY24 by \$49,200.

Expenses:

- 1) Most expense items are on track with budget. September represents 12 of 52 payrolls elapsed or 23.08%. This is the ratio that is important to use to compare wage lines to budget. It is important to note that FY25 represents 3 payrolls for July as compared to 4 payrolls for July in FY24. Other notable items are listed below.

2) Police –

- a. As of September 30, 2024, the Police Department has 13 police officer vacancies. One officer is on other leave status, three officers are in the process of being certified at the NH Police Academy. Two officers have long-term injuries. One of the injured officers is on temporary alternate duty and the second officer is expected to return to temporary alternate duty soon. There are currently two police dispatcher openings and a recruitment process is underway to fill these positions. The Department is still in a staffing crisis and struggling to backfill key positions in the department. Significant overtime is being spent to cover basic police services throughout the City. Despite significant efforts, recruitment remains challenging and is at an all-time low.
- b. Overall wages and benefits are 22% spent and \$192,000 less than FY24. Overtime is 43% spent and \$130,700 less than FY24. Included in the overall wage and benefit expenses is the annual charge, \$99,800 for workers compensation. These accounts will be closely monitored through the remainder of the fiscal year.

3) Fire –

- a. As of September 30, the Fire Department has 5 vacancies, one member on light duty and one member on injury leave.
- b. Overall wages and benefits are 27% spent and \$143,600 more than FY24. Overtime is 41% spent and \$133,700 more than FY24. Included in the overall wage and benefit expenses is the annual charge, \$516,200 for workers compensation. These accounts will be closely monitored through the remainder of the fiscal year.
