The City of Concord resolves as follows:

- WHEREAS, the Concord Police Department has received notification from the Unites States Department of Justice, Office of Justice Assistance, Patrick Leahy Bulletproof Vest Partnership (BVP) Grant Program, that we have been awarded a grant in the amount of \$13,537.50; and
- WHEREAS, the Concord Police Department provides ballistic vests for its sworn staff; and
- WHEREAS, the Concord Police Department anticipates purchasing ballistic vests in this fiscal year and in subsequent years. This grant provides a fifty percent reimbursement on qualified ballistic vest purchases by the Department; and
- WHEREAS, there is no financial match required for this grant program; and
- WHEREAS, this appropriation is for a purpose for which funding was not included in the Fiscal Year 2024 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of City of Concord that:
