The City of Concord resolves as follows:

- WHEREAS, the FY2020 Capital Improvement Program (CIP) included CIP 588 for the rehabilitation and improvement of the NH Route 9 / Loudon Road Bridge (163/111) over the Merrimack River ("the Project); and,
- **WHEREAS**, in October 2020 the City Council selected Alternative #5 for the widened deck and multi-use corridor design associated with the Project; and,
- **WHEREAS**, in September 2021, a Design Alternative Study for the Project was completed; and,
- **WHEREAS,** coordination with State officials regarding the Project and the proposed I-93 Bow/Concord Widening project continued through 2022; and,
- WHEREAS, CIP #588 is part of the NHDOT's Municipal Bridge Aid Program and is included in the State's Ten-Year Plan (STIP) as NHDOT Project CONCORD 41212; and,
- WHEREAS, CIP #588 / NHDOT Project CONCORD 41212 includes the following components: design, permitting, right-of-way, and construction of a new bridge over the Merrimack River; and,
- **WHEREAS,** the total estimated cost of the Project, as included in the State's Ten-Year Plan, is \$23,484,140, of which 80% shall be Federal/State funds and 20% shall be City funds; and,
- **WHEREAS**, the City desires to proceed with this project.
