Comments, Requests by Mayor, City Councilors

Action: Councilor Hatfield inquired as to the status of the grant program established at the last City Council meeting to assist restaurants within the community with the procurement of PPE products in advance of restaurants going back to full inside seating. Deputy City Manager Baia indicated that the Economic Development Director was working with the Chamber of Commerce on this grant project. He further stated that they had reached out to all restaurants within the community to advise them of the grant opportunity. No additional information was available.

Councilor Champlin noted that it was nice to see all the new volunteers at polling locations within the City at the recent November State General Election. He further stated how nice it was, as someone who typically stands outside all day at the polls, to be part of such a positive experience.

Councilor Pierce thanked the Clerk's Office for their efforts in securing the new Ward Two polling location, The Barn at Bull Meadow, indicating his hope was that the City of Concord could continue the partnership for years to come.

Councilor Pierce inquired as to how the new leaf pick up equipment was working. City Manager Aspell indicated all was working well.

Councilor Keach commended the City Clerk, and members of the City Clerk's Office, on all of the work related to the recent November 3, 2020 State General Election.

Councilor Fennessy thanked the City Clerk, the Clerk's Office staff, as well as ward officials and the many volunteers that worked at the polls on November 3rd. He further indicated he received positive comments from residents within Wards Two and Seven specific to the changes in polling locations for those respective wards.

Mayor Bouley thanked the City Clerk, her office staff, as well as the many residents within the community for the hard work, long hours and dedication specific to the Election process.

Comments, Requests by the City Manager

Action: Deputy City Manger Brian LeBrun indicated that Unitil, on behalf of the City of Concord, had petitioned the Public Utility Commission to extend the on bill financing loan program as part of the LED street light relamping program, which the City is working with Unitil on. He further stated that the order from the Public Utilities Commission granted the request by Unitil to provide the non residential energy efficiency loan program to the City of Concord, with a condition that allows a comment period through November 23, 2020. If no objections are received, the order would be in place and the City could move forward at that time.

Deputy City Manager LeBrun further indicated he would anticipate bringing forward a resolution within the December Council agenda for a January public hearing for the overall approval of this proposed program.

City Manager Tom Aspell indicated that the Concord School District recently voted to approve moving forward to work with the City and the Abbot Downing Historical Society to restore and sell the Concord Stables property to the City. City Manager Aspell noted that he would likely be bringing information to Council at a future meeting about this project.

Action: Mayor Bouley indicated that he pulled this from consent to inquire as to whether or not there were any standards specific to the design of these types of dispensers. Mayor Bouley indicated that when the Main Street project was done, discussions took place regarding Council's desire to have dispensers that fit the look of the new Main Street, as opposed to the current newspaper dispensers of various colors and designs.

Carlos Baia, Deputy City Manager Development, indicated there were no new aesthetic designs for newspaper dispensers on Main Street. He further stated that the plan was to place Hippo Press' current blue boxes in the locations noted within the report.

Following brief discussion, Council consensus was that Council's desire, when Main Street was redone, was to standardize the look of newspaper dispensers so that the look of these items fit the look of the revitalized Main Street.

Councilor Matson moved approval of the issuance of a temporary license agreement with Hippo Press, LLC, to regulate the placement of its newspaper dispensing boxes on Main Street, with the understanding that City Administration would work with staff and members of the Planning Board to standardize design of these dispenser boxes to ensure they fit aesthetically with the redesign of Main Street. The motion was duly seconded and passed with a roll call vote.

Adjournment
