RESOLUTION AUTHORIZING THE CITY MANAGER TO APPLY FOR A NEW HAMPSHIRE COUNCIL ON THE ARTS GRANT IN THE SUM OF EIGHTEEN THOUSAND DOLLARS (\$18,000), APPROPRIATING THE SUM OF EIGHTEEN THOUSAND DOLLARS (\$18,000) IN THE POCKET PARKS PROJECT (CIP #528) FOR IMPROVEMENTS OF THE CLOCK TOWER ON EASTMAN STREET, AND ACCEPTING THE SUM OF EIGHTEEN THOUSAND DOLLARS (\$18,000) FROM THE NEW HAMPSHIRE COUNCIL ON THE ARTS FOR THIS PURPOSE

The City of Concord resolves as follows:

- WHEREAS, the City wishes to restore the Eastman Clock Tower prior to a rededication event in 2024; and
- WHEREAS, the New Hampshire Council on the Arts has grant funding in the amount of \$18,000 available for this purpose; and
- WHEREAS, there is no financial match required for this grant program; and
- WHEREAS, the City wishes to accept this funding and commence the restoration of the Eastman Clock Tower (CIP #528); and
- WHEREAS, this appropriation is for a purpose for which funds were not included in the Fiscal Year 2024 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:

- 1) The City Council authorizes the City Manager to apply for and accept eighteen thousand dollars (\$18,000) in New Hampshire Council on the Arts grant funding for the purpose of restoring the Eastman Monument.
- 2) The sum of\$18,000
be and is hereby appropriated as follows:

General Capital Project Fund
Pocket Parks (CIP #528).....\$18,000
