Dear Ms. Bonenfant:

Back in June 2024, I approached Mayor Champlin to see what if, anything, the City of Concord was planning for our nation's upcoming semiquincentennial on July 4, 2026. We exchanged emails and he referred me to Rik Yeames who had also expressed an interest in getting the ball rolling.

Since then, Rik Yeames and I have set up a few meetings with Mayor Champlin, Tim Sink of Greater Chamber of Commerce to brainstorm on what the city could put out there for the city of Concord/public and the city of Concord's ultimate role to lead the charge and be the fiscal agent of any such event(s) by forming an Ad Hoc Semiquincentennial Committee. At our last meeting, Mayor Champlin suggested that in order for our planning committee to move forward, we needed to get the city of Concord on board. He would approach the City Council and the City Manager to nominate Rik Yeames and myself to become an active part of such a committee going forward. We both have presented many ideas and have already made connections with members of various organizations expressing an interest in getting involved, including local high schools' class of 2026, Brian Blackenden planner of annual Grange Holiday parade and others, who would love to become part of this major city event. I had already enlisted 12 or more volunteers as well. I scheduled a meeting in August with David Gill of Recreation & Parks regarding any proposed events to take place within a city park and protocols in place.

We discussed starting out in sub-committees to focus on a major downtown July 4, 2026 parade; picnics in the local parks (12 to 4) and then ending with a massive fireworks display at Memorial

Field. Maybe even incorporating a few kick-off events prior to actual date and getting the State involved. We knew what a massive undertaking this would be and realized early on, that we could not move forward until the City of Concord became an integral part of the planning and thus, the Mayor suggested forming an Ad Hoc committee.

I have been retired for several years now but have attached my working resume as well as a listing of my extensive 45 plus years of organizing, committees I have chaired over the years as well as extensive volunteer work. It would be an honor for me to be nominated and accepted as a member of this City of Concord- Ad Hoc semiquincentennial committee. My parents (now both deceased) were very involved in the organization of all past Heights Fourth of July parades/picnic from 1950-1970. It would be a nice tribute to bring back that tradition they started on the Heights but now for the city of Concord on July 4, 2026.
