Subject: Rollins pool lifeguards

Too often people are quick to complain but compliments and a job well done seem to be few and far between.

Over the past few weeks I have been taking my son to the pool at Rollins park 2,3 sometimes 4 times a week and I can say it was one of the highlights of our summer. It did not go unnoticed the great job the pool staff did.

They did such a good job balancing the duties of keeping the guests safe as well as being kind and polite. I recently saw a Facebook post stating how the staff was rude and cold. Clearly that person doesn't understand that the safety of each guest is a higher priority than making sure that feelings might get hurt.

On the rare occasions when the pool was nearly empty I had the opportunity to talk to some of your staff. We chatting about how the summer was going and about their job. One young man told me he was surprised how much he had to tell adults to behave and be more responsible. I wish I was also surprised but I wasn't.

I was also present one evening when two boys (I'm guessing were 13) were acting as boys that age sometimes act. With just a handful of people left in the pool used the classic "time out" with the boys as a teaching moment. The boys who probably aware of the differences in gender identity but not aware that such language could be used in a way that could be hurtful. Instead of kicking them out of the pool (which is what I probably would have done) they put the boys in a timeout to try to explain in a very polite way that they should be more cognitive of their choice of words. It probably fell on deaf ears but the attempt was noticed and I hope my son won't act that way, but if he does I would welcome a similar attempt.

In closing again I would like to say the young men and women at the Rollins park pool were a great team. And if you could please share with them my thanks.
