The City of Concord resolves as follows:

- WHEREAS, the City Council, at its meeting on September 12, 2016, authorized the City Manager to apply for grant funds from the NH Department of Environmental Services (NHDES) Aquatic Resource Mitigation Program in conjunction with the Portsmouth Street Culvert Replacement Project (CIP #83); and
- WHEREAS, on December 12, 2016, NHDES provided notice that Concord had been awarded \$100,000 in Aquatic Resource Mitigation Grant Program funds for the design and construction of culvert replacement and stream bed restoration improvements along Mill Stream at Portsmouth Street; and
- WHEREAS, the grant funds will be added to previously appropriated funds in the amount of \$275,000 for CIP #83, including \$400,000 appropriated in Resolution No. 8852, dated June 25, 2015, and subsequent reduction of \$125,000 redirected in Resolution No. 8870, dated September 14, 2015, to complete Storrs Street drainage improvements replacing failed pipe systems under I-93; and
- **WHEREAS,** the City Engineer has identified the need to commence the design and construction of these improvements; and
- **WHEREAS,** the appropriation is for a purpose not included in the Fiscal Year 2017 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of all members of the City Council.
