### The City of Concord resolves as follows:

WHEREAS,	the Concord Police Drug Enforcement Unit conducted investigations which resulted in the arrest of two defendants on illegal drug related charges; and
WHEREAS,	during the course of these investigations the Drug Enforcement Unit seized \$36,013 of US currency as evidence associated with the illegal drug crimes of the two defendants; and
WHEREAS,	the Merrimack County Superior Court issued a disposition in docket # 217-2015-CR-00881 and docket #217-2015-CR-00865, wherein each defendant voluntarily forfeited this currency as part of plea agreements approved by the Court; and
WHEREAS,	these funds were stipulated by the plea agreement to be utilized by the Concord Police Department Drug Enforcement Unit in furtherance of illegal drug investigations within the City; and
WHEREAS,	there is no financial match required by the City; and
WHEREAS,	this appropriation is for a purpose not included in the Fiscal Year 2017 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.

### NOW, THERFORE, BE IT RESOLVED by the City Council of City of Concord that:
