AUTHORIZING AND APPROPRIATING EIGHTY ONE THOUSAND FIVE HUNDRED FIFTY SEVEN DOLLARS (\$81,557) AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH AFFINITY LED LIGHTING FOR THE PURCHASE AND INSTALLATION OF A LED LIGHTING PROJECT AT THE EVERETT ARENA AND TO ENTER INTO AN AGREEMENT WITH UNITIL TO ACCEPT A GRANT FOR FORTY THOUSAND SEVEN HUNDRED SEVENTY EIGHT DOLLARS AND FIFTY CENTS (\$40,778.50) AND TO FINANCE FORTY THOUSAND SEVEN HUNDRED SEVENTY EIGHT DOLLARS AND FIFTY CENTS (\$40,778.50) AS ON BILL FINANCING.

The City of Concord resolves as follows:

- **WHEREAS**, the City has been working with Affinity LED Lighting since March 2016 to develop an LED lighting project at the Everett Arena; and
- **WHEREAS,** the total cost of the project is expected to be approximately \$81,577 of which 50% (\$40,778.50) will be a direct grant to the vendor from Unitil and the remaining 50% (\$40,778.50) will be on bill financing from Unitil for an expected period of 51 months and will not exceed 60 months; and
- **WHEREAS**, the electrical savings from the LED lights are showing a payback of 4.25 years and the on bill financing payments will be about the same as the electrical savings on an annual basis; and
- **WHEREAS**, there is no specific guarantee of electricity savings and instead proven savings from a similar project in Dover New Hampshire and confirmation that the savings calculations make sense from the City's independent consultant; and
- WHEREAS, work is anticipated to commence in May 2017; and
- WHEREAS, the Director has identified the need to begin work on this project; and
- **WHEREAS,** this appropriation is for a purpose not included in the Fiscal Year 2017 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council; and
- **WHEREAS**, this resolution contains language authorizing the City to enter into a loan agreement with Unitil, it requires a two thirds vote of the City Council under RSA 33:9.
