**Action:** Mayor Bouley opened the public hearings for recessed items A through D.

There being no public testimony, the Mayor closed public hearing items A through D.

**Action:** City Manager Tom Aspell provided a brief overview.

Councilor Werner noted that this item was unanimously endorsed by that Tax Exemption Policy Committee. He feels that in addition to the environmental aspect and the advantages of solar, this develops an economic development opportunity to the city. He feels that this may bring more companies into the city and also feels that this is a benefit for the community.

Councilor Nyhan recognized city staff for their work on this item. He feels that, financially, this is a good decision and urged Council to support this resolution.

Councilor Todd noted his support adding that there may be existing companies that want to do the right thing.

Mayor Bouley opened the public hearing. There being no public testimony, the Mayor closed the hearing.

The motion was duly seconded and passed 14 to 0 on a roll call vote with Councilor Bouchard, Mayor Bouley, Councilors Champlin, Coen, Grady Sexton, Herschlag, Keach, Kenison, Kretovic, Nyhan, St. Hilaire, Shurtleff, Todd and Werner voting yes.

9. Resolution for annual capital closeout and repurposing of capital project funds; together with a report from the Senior Accountant.

**Action:** Councilor Nyhan moved approval. The motion was duly seconded and passed with no dissenting votes.

**Action:** Councilor Nyhan moved approval of the June 26th revised resolution. The motion was duly seconded and passed with no dissenting votes.

#### **New Business**

**Action:** Councilor St. Hilaire moved, in accordance with RSA 273-A:3, II(c), to approve the cost items included in the collective bargaining agreement from July 1, 2017 through June 30, 2020 between the International Association of Fire Fighters - Local 1045 ("IAFF") and the City of Concord. The motion was duly seconded and passed with no dissenting votes.

In regards to the City Manager's Performance Evalution, Councilor St. Hilaire explained that by Charter, the City Council rates the City Manager's performance as either "satisfactory" or "unsatisfactory".

Councilor St. Hilaire moved to give City Manager Tom Aspell a satisfactory rating. The motion was duly seconded and passed with no dissenting votes.

Councilor Kretovic moved acceptance of the City Manager's proposed contract and increase his salary three percent and increase retirement to 9.5 percent. The motion was duly seconded and passed with no dissenting votes. (The City Manager's contract is on file at the City Clerk's Office)

#### Comments, Requests by Mayor, City Councilors

Councilor Shurtleff announced that on Friday, June 30th, at 10:00 a.m. the dedication of the John Winant Memorial will be held at the State Library.

Mayor Bouley recognized and noted his appreciation of City Manager Tom Aspell. He indicated that the city is run professionally by him and if Council could vote for something more than satisfactory they would do so. He stated that the adopted budget reflects a balance that they all struggle with and gives the manager the tools to run the city smoothly.

#### **Comments, Requests by the City Manager**

City Manager Tom Aspell thanked the Council for their vote and his contract. He additionally thanked staff.

#### **Adjournment**

The time being 7:26 p.m., Councilor Kretovic moved to adjourn the meeting. The motion was duly seconded and passed with no dissenting votes.
