Allan,

Thank you so much for your thoughtful response. I will answer your questions in the order your posed them.

Is the disruptive noise only during the winter when snow is being removed?

No, we have had issues with other disruptive noises. As residents we manage to live through motorcycle noise, excessive music from motorcycles and cars, and other disturbances from traffic (especially at the Loudon St. and North Main St. junction). However, these are not our primary concern. Snow removal is the most consistent disturbance, but this summer the city also conducted construction projects from midnight to 5 or 6 AM. Road maintenance crews and other workers used heavy equipment, tore through pavement, and kept everyone awake in the building with their extremely bright lights and excessive noise. I made calls to city staff and police when road maintenance workers were ramming a bucket on a piece of heavy machinery into the brick sidewalk to "repair" it at 2 AM.

Does it also occur during plowing of the street and sidewalks and is this at night? The noise disturbances from plowing the streets and sidewalks and snow removal occurs between the hours of midnight and 5 AM. This is the most disruptive situation because of the

beeping from heavy machinery and the noise of metal scraping pavement.

Are there other activities that occur on Main Street throughout the year that cause similar disruptions?

Mainly, construction projects that occur at night.

During conversations leading up to the Main Street project I had strongly advocated for a heated sidewalk and roadway. This would have eliminated the snow removal disruptions as no plowing

or snow removal would have been necessary.

Do you have any suggestions as to how this issue can be remedied?

As a solution to the current situation, I propose the City of Concord follow its own noise ordinance rules. Construction and snow plowing should occur in the early evening/evening and early morning (after 6 AM). Concord truly is a 9-5 city and I do not predict the city would encounter many issues plowing side walks and conducting snow removal activities after dinnertime and before bedtime.
