The City of Concord resolves as follows:

- WHEREAS, the project was noted as CIP #571 in the FY 2015 and 2016 Capital Budgets; and
- *WHEREAS*, Resolution #8852 approved at the FY 2015 budget adoption appropriated \$140,000 of City funds; and
- WHEREAS, Resolution #8887 approved at the FY 2016 budget adoption appropriated \$610,000 including \$466,668 from the State and \$143,332 of City funds for the purpose of design and construction of the I-393/Horseshoe Pond Drainage Improvements and Watershed Management Study; and
- *WHEREAS*, the amount of \$188,323.50 in City funds remains unspent, and
- WHEREAS, the amount of \$466,668 in State funds remains unspent, and
- *WHEREAS*, City staff recommends using the remaining \$188,323.50 in City funds for the design of Phase 1 stormwater improvements to manage and treat stormwater that is conveyed to the intersection of I-393, North Main Street and Bouton Street; and
- *WHEREAS*, de-authorize the State's remaining \$466,668.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Concord that:

1. The sum of\$188,323.50 be and is hereby repurposed for the design of Phase 1 stormwater improvement as described above.
