The City of Concord resolves as follows:

- WHEREAS, the Fiscal Year 2018 Project Inspection Fund operating budget is overspent due to additional inspection services and \$56,100 is needed to align the approved budget with actual expenditures; and
- WHEREAS, the Fiscal Year 2018 Golf Fund is in need of a reversal of \$76,350 of the transfer to General Fund for overhead charges as part of the solution to keep the Golf Fund working capital positive; and
- **WHEREAS,** for Fiscal Year 2018 an additional amount of \$48,000 is needed to be transferred from the General Fund to the Golf Fund as the remaining part of the solution to keep the Golf Fund working capital positive; and
- **WHEREAS,** funds to support the Inspection Fund portion of this appropriation are derived entirely from additional inspection revenue received during Fiscal Year 2018; and
- **WHEREAS,** funds to support the General Fund transfer to the Golf fund will supported by available fund balance; and
- WHEREAS, this appropriation is for a purpose not included in the Fiscal Year 2018 adopted budget, therefore, Section 37 of the City Charter requires a two-thirds vote of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:
