WHEREAS, the City of Concord is eligible to apply to the New Hampshire Community
Development Finance Authority, Community Development Block Grant

Program Division, for a Community Development Block Grant (CDBG); and

WHEREAS, the City of Concord desires to continue its Community Development efforts by

performing Community Development projects, including, but not limited to: providing housing rehabilitation assistance to low and moderate income individuals or families, as well as construction and rehabilitation assistance for

Public Facilities that will provide jobs and services for low and moderate

income individuals or families; and

WHEREAS, Community Development funds are available through the New Hampshire

Community Development Finance Authority, Community Development Block

Grant Program Division, to assist such projects; and

WHEREAS, the 190 Manchester Street Manufactured Housing Park Co-operative proposes

to utilize these grant funds in order to repair and replace deteriorated

infrastructure, including, but not limited to, sanitary sewer and potable water

systems and related infrastructure; and

WHEREAS, the 190 Manchester Street Manufactured Housing Park Co-operative shall be

responsible for raising the required matching funds to support this grant

application; and

WHEREAS, this appropriation is for a purpose not included in the adopted budget,

therefore, section 37 of the City Charter requires a two-third vote of the

City Council.
