The City of Concord resolves as follows:

- **WHEREAS**, the Fiscal Year 2018 Capital Improvement Plan approved \$250,000 for the Pump Station #5 Refurbishment and Upgrade (CIP #372); and
- WHEREAS, the original 1981 pumps, motor, and controllers have become less reliable and deficiencies were noted in the last Sanitary Survey by New Hampshire Department of Environmental Service (NHDES) in the pump station's chemical containment area; and
- **WHEREAS,** current pumps and controllers offer no flexibility to the pumping rate out of the Contoocook River and staff and environmental safety concerns must be addressed; and
- **WHEREAS**, the original engineer's estimate was approximately \$250,000, the design work has been completed and there is \$189,800 remaining, a Request for Proposal was issued, the low bid was \$475,000 leaving a shortfall of \$285,200; and
- **WHEREAS**, the General Services Department has determined this capital improvement must be completed as designed; and
- WHEREAS, a supplemental appropriation of \$285,200 is needed to complete the project (CIP #372); and
- **WHEREAS**, RSA 33:9 mandates that two-thirds vote of all members of the City Council is required to pass a bond resolution; and
- **WHEREAS**, this appropriation is for a purpose not included in the Fiscal Year 2019 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:

1) The sum of\$285,200 be and is hereby appropriated as follows:

- 3) In order to meet said expenditure, the City Treasurer, with the approval of the City Manager, is authorized to issue up to \$285,200 in bonds and notes of the City of Concord under RSA 162-K: 8, Chapter 280 of the Acts of 2000, and/or the Municipal Finance Act.
- 4) The discretion of the fixing of dates, maturities, rates of interest, form and other details of such bonds and notes, and providing for the sale, is hereby delegated to the City Treasurer.
- 5) The useful life of the project is expected to be in excess of ten (10) years.
- 6) Sums as appropriated shall be expended under the direction of the City Manager.
- 7) This resolution shall take effect upon its passage.
