## The City of Concord resolves as follows:

- WHEREAS, the Concord Police Department has played an integral role in the development of an Adverse Childhood Experience Response Team Program in the Concord area, which is designed to serve and offer resources to children who have been exposed to violence; and
- WHEREAS, the Concord ACERT Program will be administered by the Merrimack County Child Advocacy Center which has received funding through the Granite United Way; and
- WHEREAS, the Concord Police Department desires to utilize this funding through the Merrimack County Child Advocacy Center for reimbursement of overtime costs associated with the Department's participation in ACERT activities in assisting children exposed to violence; and
- **WHEREAS,** there is no financial match required for this program; and
- WHEREAS, this appropriation is for a purpose not included in the Fiscal Year 2020 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.
