Action: There being no Council objection, City Clerk Janice Bonenfant read the titles together.

Mayor Bouley opened the public hearings for items A through F. He indicated that they will be recessing the hearings and taking further testimony on June 17th at 7:00 p.m.

# Public Testimony

Craig Greenman, Maple Street resident, noted his concern with the hardship that

tax increases have on residents. He is not opposed to taxes or government because he enjoys having the stability of government but feels that this is a progressive issue because there are a number of people within the city that are having a hard time affording. Referencing the increase in the Police Department budget, he believes that Concord is over-policed and that the Police Department is over-budgeted. He highlighted the voters and their differences that showed up to vote last Tuesday pointing out that some don't feel that they count; the ones that don't feel like they count tell individual stories about their lives. He feels that, as a city government, they are having a hard time hearing some of the stories with the city budget being an example. He pointed out that ninety percent of Ward Four did not vote and feels that this should affect the Council and affect the way that they are crafting this budget.

Councilor Coen stated that approximately thirty three percent of the total tax goes to the municipal side; one-third of it the city controls and two-thirds they don't.

Roy Schweiker, resident, feels that the city needs to consider more of a seven day a week operation referencing the Library, Parking Enforcement, the community center and the highway department. He feels that the leaf collection program is ineffecient and feels that the city should do leaf collection in blocks or segments so that its easier for residents to figure out. He noted his concern in regards to the growth and population within the city. Lastly, he doesn't feel that the city should support a particular religious denomination or a particular ethnic group.

J. Richard Jaques Sr., Penacook Community Center Executive Director, thanked the Mayor, the City Manager and City Council for their continued support. He noted that the funds that the center recieves from the city allows them to ensure that those living in their community have opportunities to engage in ways that are meaningful to them. He stated that the funds received from the city supports their ability to provide scholarships and high quality programs. (Written testimony on file in the City Clerk's Office)

Councilor Keach inquired as to what other communities are served, besides Penacook. Mr. Jaques responded that they service seven to eight different towns outside of Concord. Councilor Keach questioned whether the community center receives any funding from any of the other communities. Mr. Jaques replied that they do - \$5,800 per year from Boscawen and \$500 per year from Webster. He added that most of their participants do come from Concord and Penacook. There being no further public testimony, public hearings A through F were recessed until June 17th.

Mayor Bouley indicated that Council will be having a work session prior to the June 17th Council meeting. He announced that they will be holding a non-public session on June 17th beginning at 5:30 p.m. to discuss the City Manager's contract.
