WHEREAS,	the City of Concord and the County of Merrimack entered into an MOU stipulating that the City was to receive \$19,540 and the County was to receive the remaining \$3,000; and	
WHEREAS,	the City Council approved Resolution #9134 on September 10, 2018, authorizing the City Manager to accept and appropriate the sum of \$22,540 in unmatched grant funds; and	
WHEREAS,	as the result of a misunderstanding, the County of Merrimack submitted an application for, and was subsequently awarded, these funds, and	
WHEREAS,	the Department of Justice received the application from the County of Merrimack prior to that of the City of Concord, and the City's application for funding was thusly denied; and	
WHEREAS,	the City of Concord and County of Merrimack are entering into a new Memorandum of Understanding for the County to pass-through \$19,540 to the City of Concord; and	
WHEREAS,	the City of Concord will be a sub-recipient to the County of Merrimack which is acting as the primary recipient and fiscal agent for the grant; and	
WHEREAS,	this resolution rescinds and de-authorizes \$3,000, and upon passage of this resolution, there will remain an appropriation of \$19,540 for this purpose.
