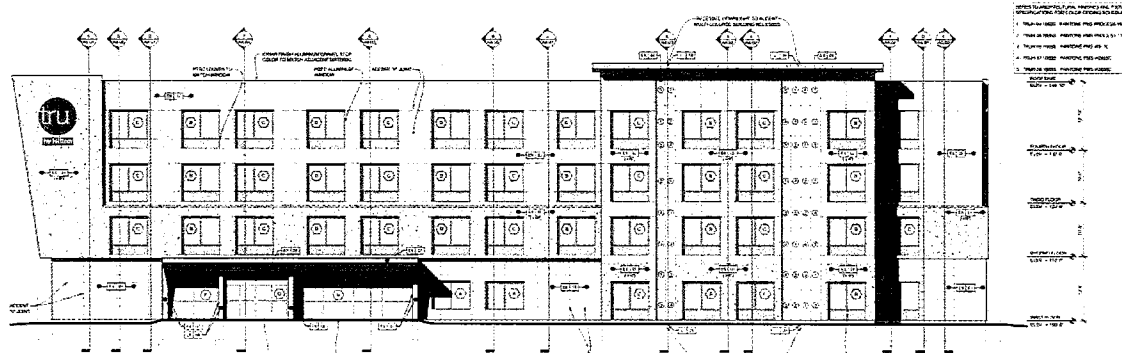

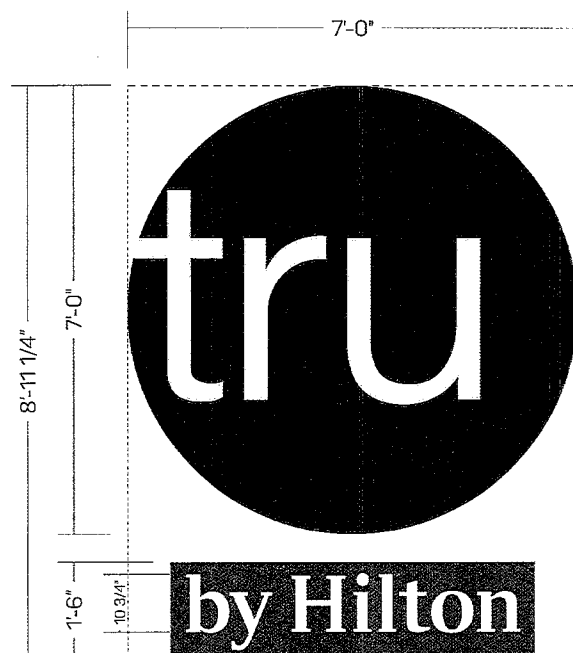

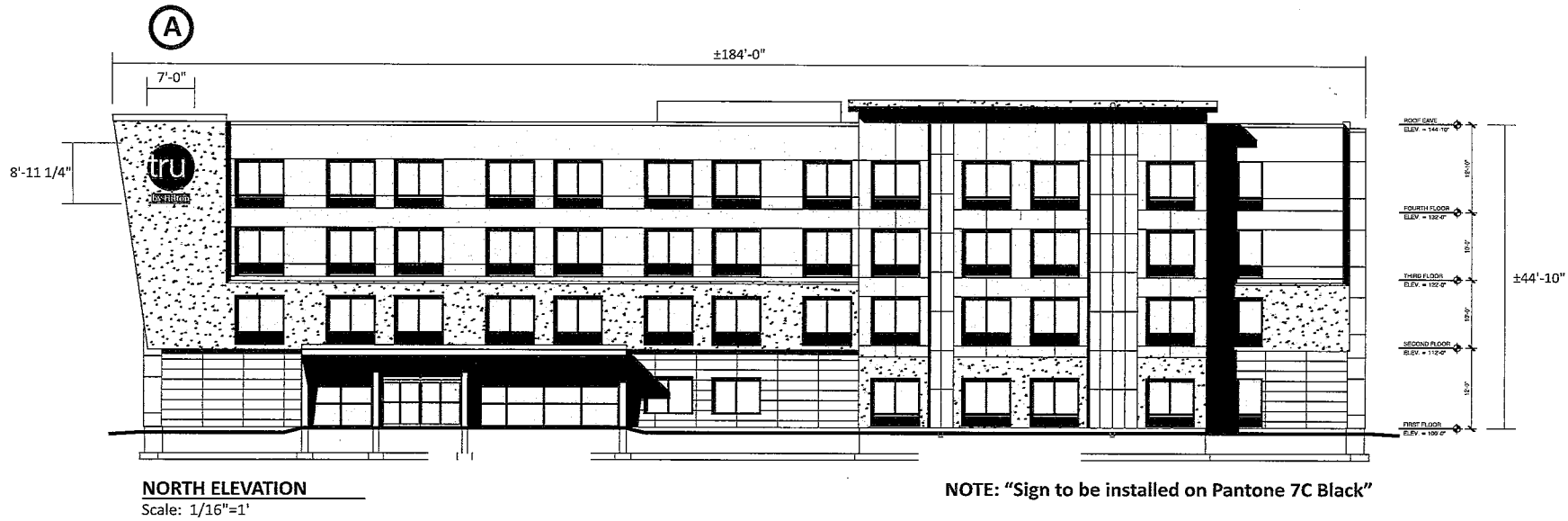

Dimensions:

- Overall width: 7'-0" CABINET
- Overall height: 8'-11 1/4"
- Headboard height: 7'-0"
- Headboard width: 3'-3 1/2"
- Footboard height: 5 1/4"
- Footboard width: 1'-5"
- Base height: 10 3/4"
- Base width: 5'-4 5/8"
- Base depth: 5'-8"

Assembly Steps:

1. Attach the headboard to the base.
2. Attach the footboard to the base.
3. Attach the base to the frame.
4. Attach the frame to the base.

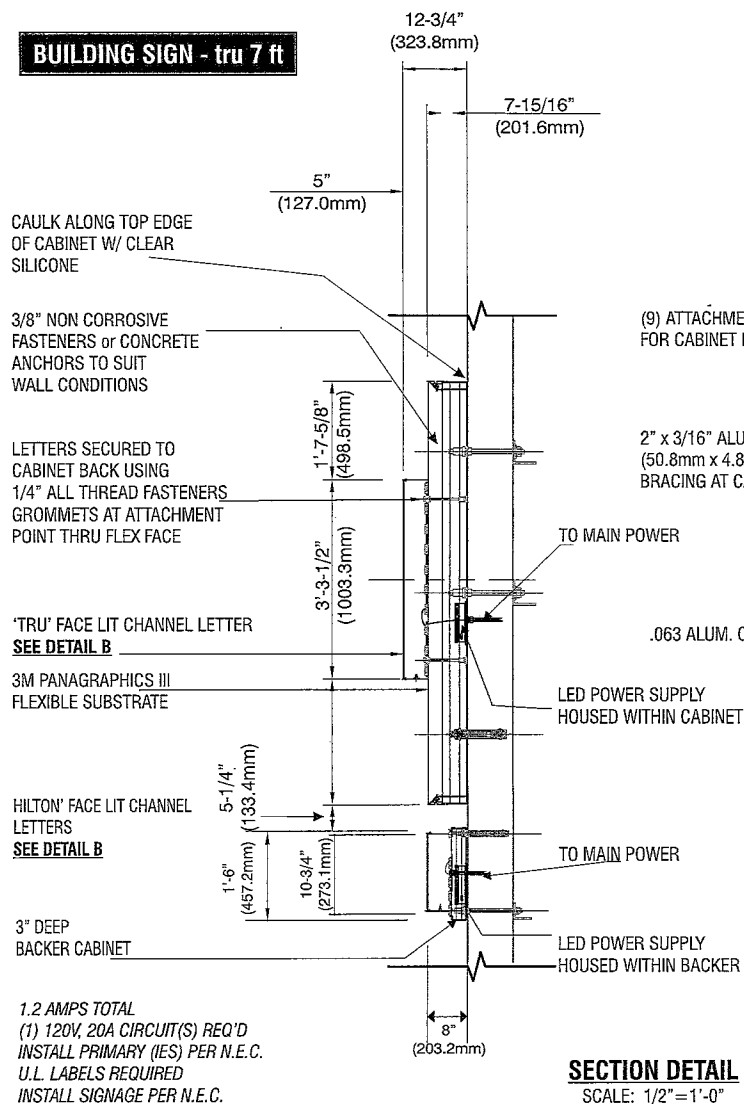

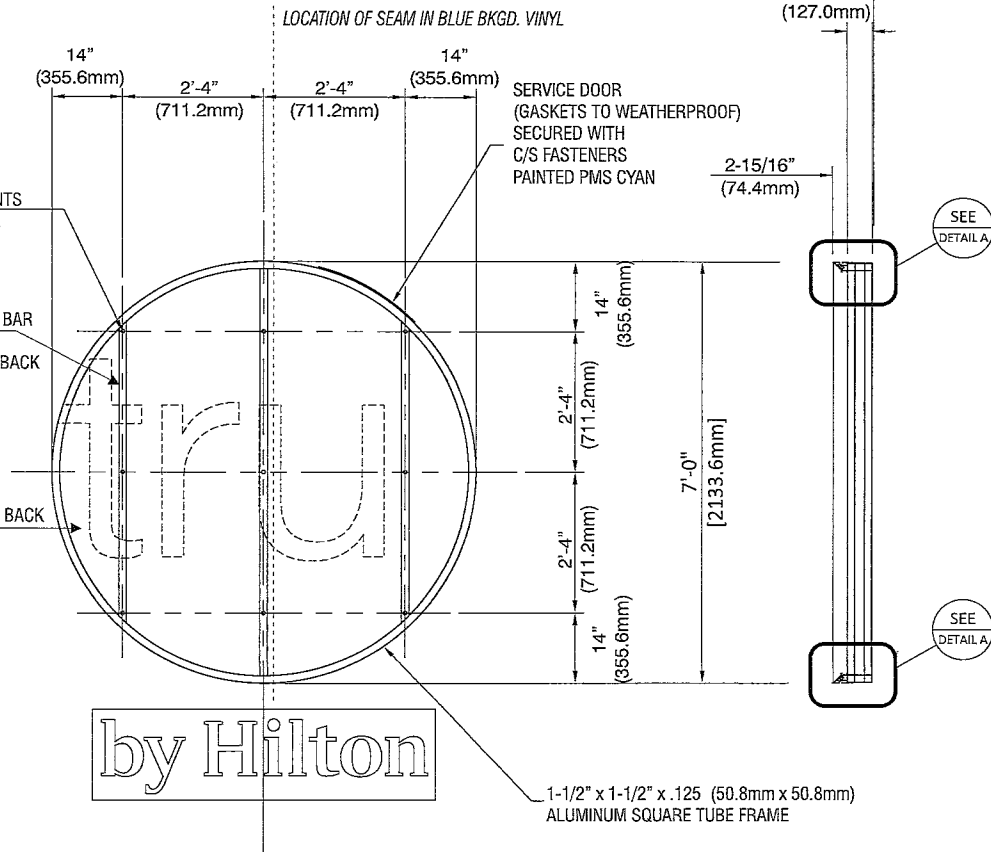

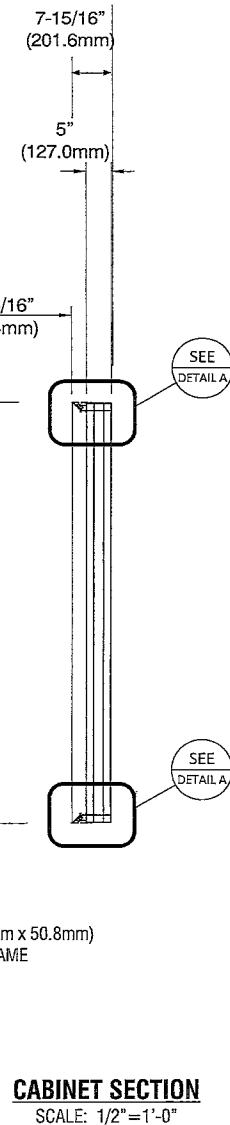
