The City of Concord resolves as follows:

- WHEREAS, on June 9, 2014 the City adopted resolution #8777, which authorized the issuance of Sears Block Tax Increment Finance District supported bonds and notes in the amount of \$1,900,000 to acquire the former New Hampshire Employment Security property located at 32 South Main Street and 33 South State Street ("the Property") (CIP #578); and
- WHEREAS, on June 9, 2014 the City adopted resolution #8778, which authorized the issuance of Sears Block Tax Increment Finance District supported bonds and notes in the amount of \$90,000 for weatherization of the former New Hampshire Employment Security property located at 32 South Main Street and 33 South State Street; and
- WHEREAS, on October 31, 2014, the City acquired the former New Hampshire Employment Security property located at 32 South Main Street and 33 South State Street; and
- WHEREAS, of the \$1,990,000 appropriated by Resolutions #8777 and 8778, only
 \$1,850,000 was expended to acquire and weatherize the Property, therefore the City desires to de-authorize and rescind unused portions of these appropriations; and
- WHEREAS,
 on November 13, 2017 the City adopted resolution #9053, which authorized the issuance of Sears Block Tax Increment Finance District supported bonds and notes in the amount of \$300,000 for demolition of the former New Hampshire Employment Security building in accordance with the terms and conditions of a January 2, 2018 Purchase and Sales / Development Agreement between the City and Dol-Soul Properties L.L.C.; and
- WHEREAS, on August 16, 2019 Dol-Soul Properties L.L.C. exercised its right to terminate the Purchase and Sales / Development Agreement concerning the sale and redevelopment of the former New Hampshire Employment Security Property, therefore the City is no longer obligated to demolish the structure and desires to de-authorize and rescind funds appropriated by Resolution #9053.
