#### The City of Concord resolves as follows:

**WHEREAS,** the City of Concord is eligible to apply for and receive funding for the purchase

of the dump truck and attachments as described in the FY 2020 Capital

Improvement Program and Budget as project #77; and

**WHEREAS,** the City's application for this purpose be accepted, project funding was to be

allocated as follows; \$225,000 (90%) Federal share, \$12,500 (5%) State and \$12,500 (5%) City share as programmed in the FY 2020 Capital Improvement

Program; and

**WHEREAS.** In March 2020 the City Council authorized the City Manager to apply for the

grant in an amount up to \$250,000; and

**WHEREAS.** The City was notified in April 2020 by the New Hampshire Department of

Transportation, Bureau of Aeronautics that the 2020 Federal Cares Act Group 1 funding was allocated to cover the cost of both the City and State shares (totaling 10% of the matching funds) for all approved 2020 Airport Improvement Projects;

and

**WHEREAS,** as a result, project funding in the amount of \$250,000 will be 100% federally

funded: and

**WHEREAS,** the Airport Advisory Committee recommends that the City Council

approve this project; and

**WHEREAS,** this appropriation is for a purpose not included in the Fiscal Year 2020 adopted

budget, therefore Section 37 of the City Charter requires a two-thirds vote of the

City Council.
