The City of Concord resolves as follows:

WHEREAS,	the Concord City Council values the preservation of significantly historic building infrastructure where possible; and
WHEREAS,	the former gas holder house located on South Main Street has fallen into substantial disrepair; and
WHEREAS,	the current owners of the former gas holder house, Liberty Utilities, in partnership with the City of Concord, commissioned a report that provided for three possible outcomes for the structure: demolition; conversion to a static monument; or redevelopment; and
WHEREAS,	Liberty Utilities has expressed that its preference is to demolish the structure by the end of 2020; and
WHEREAS,	the Concord City Council wishes to determine the viability of redevelopment of the structure; and
WHEREAS,	the New Hampshire Preservation Alliance has pledged \$4,500) toward an assessment of redevelopment scenarios for the structure; and
WHEREAS,	the Economic Development reserve has sufficient funding available to provide \$15,500 toward this assessment; and
WHEREAS,	the redevelopment assessment will: 1) Explore and assess redevelopment and stewardship scenarios, using the recent City/Liberty Utilities report as a starting point; 2) Produce options with practical financial information, suggestions about ownership/management models and recommendations for next steps; and 3) Create a document that can test interest of other private and public sector parties and help inform City's future decision- making; and
