The City of Concord resolves as follows:

WHEREAS, As part of the CARES Act, the State of New Hampshire received

approximately \$5.4 million of Community Development Block Grant Funds (CDBG-CV) to support eligible projects and initiatives to address the needs of primarily low and moderate income persons stemming from

the Covid 19 "Coronavirus" Pandemic; and,

WHEREAS, Of this total, approximately \$3.7 million is available to non-entitlement

municipalities, as well as counties, for public services on a competitive

basis; and,

WHEREAS, the New Hampshire Community Development Finance Authority

(NHCDFA) is the agency responsible for administering Community

Development Block Grant funds in New Hampshire; and,

WHEREAS, On July 20, 2020, the NHCDFA announced the programmatic rules and

application procedures for CDBG-CV funds; and,

WHEREAS, the City of Concord is eligible to apply to the NHCDFA for up to \$500,000

in CDBG-CV funding to support local non-profit organizations which provide public services to primarily low and moderate income persons

associated with the Covid 19 "Coronavirus" Pandemic; and,

WHEREAS, the City desires to apply for CDBG-CV funds to support the Friendly

Kitchen, Concord Coalition to End Homelessness, Family Promise, the Friends Program, and the City of Concord in their respective efforts to provide public services to primarily low and moderate income persons

associated with the Covid 19 "Coronavirus" Pandemic; and,

WHEREAS, this appropriation is for a purpose not included in the adopted budget,

therefore, section 37 of the City Charter requires a two-third vote of the

City Council.
