I SUPPORT AN ORDINANCE REGULATING USE OF FIREWORKS, BUT FEEL PROPOSED ONE DOESN'T GO FAR ENOUGH, MY FAMILY, MANY NEIGHBORS, AND SCORES OF OTHERS IN CONCORD FIND EXPLODING FIREWORKS AS VERY OFFENSIVE AND DISRUPTIVE TO THEIR PEACE AND QUIET, AND PRIVACY IN FRIGHTENING CHILDREN, PETS, AND PEOPLE ALIKE.
