The City of Concord resolves as follows:

- **WHEREAS**, the Fiscal Year 2020 Capital Improvement Plan included \$150,000 for replacing holding tank drain valves (CIP #466); and
- **WHEREAS**, the Penacook Wastewater Treatment Plant experienced the failure of two 24-inch process control valves which required repair on an emergency basis as reported to City Council in November 2020; and
- **WHEREAS**, the Department recommends expanding the scope of the project to include the 24-inch process control valves as well as the holding tank drain valves; and
- WHEREAS, the Department has identified two capital projects from which funds are available to be repurposed to this project, to include \$72,600 from the Fiscal Year 2017 Elevator Upgrade subproject (CIP #104) which has not been started and \$43,464 from the completed Fiscal Year 2020 Lighting Upgrade subproject (CIP #466); and
- **WHEREAS**, the department recommends appropriating the sum of \$33,936 in Wastewater Investment Fee Reserve funds for a total budget increase of \$150,000; and
- **WHEREAS**, this appropriation is for a purpose not included in the Fiscal Year 2021 adopted budget, therefore, Section 37 of the City Charter requires a two-thirds vote of the City Council.
