1. Mayor Bouley called the meeting to order at 7:00 p.m.

Action: Mayor Bouley welcomed everyone to the June 15, 2020 Electronic Meeting of the City Council, indicating City Council was meeting electronically due to the COVID-19/Coronavirus pandemic, in accordance with Governor Sununu's Emergency Order #12, pursuant to Executive Order 2020-04. Mayor Bouley noted that, in accordance with the Governor's Emergency Order, we have provided public notice of the necessary information for accessing this meeting. He noted that instructions are provided on our agenda on the City of Concord's website at: https://concordnh.legistar.com/Calendar.aspx. He further noted that Council was utilizing the Zoom platform for this electronic meeting. All members of the City Council have the ability to communicate contemporaneously during this meeting, and the public has access to listen and, if necessary, participate in this meeting via the following website address: https://us02web.zoom.us/j/85746102836.

Mayor Bouley noted that we would not be using the Chat function in Zoom for this meeting. He also noted that testimony is only allowed for agenda items that have been scheduled for a public hearing, and public participation is not authorized for the other items on the agenda.

The Mayor indicated that in the event the public is unable to access the meeting, the meeting would be adjourned and rescheduled at that time.

All votes to be taken during this meeting will be done by roll call vote.

Mayor Bouley asked members of City Council, when stating their presence at the meeting, to please also state whether there was anyone in the room with them during this meeting, which is required under the Right-to-Know law.

June 4, 2020 Finance Committee Draft Meeting Minutes.

Action: Councilor Bouchard moved approval of the June 4, 2020 Finance Committee meeting minutes. The motion was duly seconded by Councilor Matson and passed unanimously with a roll call vote.

Action: Mayor Bouley provided an overview of the budget items before Council, recommending that Council open all public hearings on the agenda at the same time so the process was easier for the public.

Public Hearings

7. Resolution fixing and determining the amount of money to be appropriated by the City of Concord for the Fiscal Year 2021, ending June 30, 2021, for the General Fund, Special Revenue Funds, Enterprise Funds, Debt Service Funds and Diminimis Accounts.

Action: There being no Council objection, the City Clerk read the titles for public hearing items 7 through 10 together.

Mayor Bouley opened the public hearings for items 7 through 10.

Public Testimony

Rachel Venator spoke in opposition to increases to the Police Department's FY

2021 budget, in the wake of recent current events. Councilor Hatfield thanked Ms. Venator for her testimony and, for the record, asked Ms. Venator which ward she resided in within the City of Concord. Ms. Venator indicated that she used to live in ward ten within the City, further stating she was away for work, considered Concord her home and planned to return to Concord.

Carlos Baia, Deputy City Manager - Development, read five public testimony items into the public record from resident Roy Schweiker. All five communications are on file in the City Clerk's Office.

In response to Mr. Schweiker's concern about the electronic City Council meeting format, which requires participants to either have internet access or pay by the minute for a long distance call in order to participate in Zoom meetings, Councilor Kretovic indicated that, to the best of her knowledge, callers didn't incur per minute charges as long as they were calling in on the line designated for their county. City Manager Aspell indicated he thought the City of Concord's Zoom account charged a per minute fee for anyone calling in on a land line.

Councilor Kretovic suggested that perhaps something should be posted on the door to the Library letting residents know that the emergency hot line number to NH Employment Security is 271-7000.

Councilor Hatfield asked for clarification on reference she had received on the million dollar increase within the Police Department budget. City Manager Aspell explained that, specific to the Police Department, the following changes are proposed within the FY 2021 budget being considered this evening: 1) changes in health insurance plans to a high deductible plan, which saves dollars on the benefit costs for taxpayers, noting that the negotiated change for that was an increase in salaries within the Police Department to help offset that change in benefit; 2) increases in patrol costs; changes in salary dollars to make Concord Police patrol salaries more competitive when compared to other departments in the State in order to attract more quality officers; and 3) the addition of a Deputy Chief position, approved by Council in January 2020, to address mentoring/training needs within the department specific to the reality that the Concord Police Department has a very young organizational structure with the majority of patrol officers working five years or less with the City.

There being no additional public testimony, Mayor Bouley closed the public hearings for items 7 through 10.

Councilor Champlin inquired as to whether or not the approximate one million dollars included capital expenditures. City Manager Aspell indicated only minor capital expenditures were included, clarifying the total proposed increase for the Police Department was \$797,436. Councilor Champlin asked for clarification that approximately \$790,000 of that \$797,436 was for wages and fringe benefits. City Manager Aspell indicated that to be correct.

Councilor Kenison asked for clarification that the City of Concord was focused on more community policing. She also inquired about what initiatives the Police Department might be taking in terms of reviewing their policies and procedures specific to use of force, in light of the black lives matter interest in our country.

Police Chief Brad Osgood indicated that the Police Department has been doing a lot of community policing, for a number of years. Specific to the question as to what the Police Department was doing for reforms, Chief Osgood indicated that the department recently published their use of force policy on the City's website. He further indicated that, as a command staff, the department would continue to look at different opportunities while working with other police departments and associations to determine that they are using best practices here in Concord.

Councilor Todd asked Chief Osgood to clarify comments regarding streamlining the department's hiring process. Chief Osgood indicated that, historically, it has been very difficult to get applicants to come in and take entrance exams, explaining that the department has created an on demand type hiring process where as soon as applicants apply they are contacted and brought in for an interview. Chief Osgood explained that the department can now interview a candidate and give the written and physical agility tests all in one day, rather than having potentially hundreds of candidates show up for testing all at the same time on a given day. Chief Osgood indicated candidates still have to take a polygraph, a psychological exam, a medical check and a drug screening; and clarified that the process is changed in the sense that the department can now work with a single candidate instead of a large group.

Councilor Todd, specific to training, asked Chief Osgood to explain Concord's training practices. Chief Osgood indicated that once an officer is hired they are assigned to a lieutenant for three weeks prior to attending the police academy. He

indicated that after attending sixteen weeks of training at the Police Academy a given officer is assigned to a field training officer for an additional sixteen weeks prior to working on their own.

Councilor Werner commented that it might be advantageous, a good public service, to communicate exactly what the City of Concord training protocols are in order to better communicate to our citizens exactly how trained and competent our officers are.

Councilor Champlin asked the Chief if it would be fair to say that even though we are streamlining the hiring process in order to meet our needs and fill current vacancies, we are in no way diminishing the stringency in which the City is recruiting, nor the training that is required in order to become an officer at the Concord Police Department. Chief Osgood indicated that to be correct, confirming that the Concord Police Department was in no way lowering their hiring and training standards.

Mayor Bouley indicated he received approximately 50 form emails from an organization called defund12.org urging that Concord government officials demand City Council adopt a budget for the people and defund the Police Department. Mayor Bouley further stated that of all the emails he received, 22 of them were from Concord residents, the other approximate 28 appearing to either be non-Concord and/or residents of other states. Mayor Bouley indicated he would forward those communications to the City Clerk for the public record.

Councilor Fennessy thanked Chief Osgood for putting the use of force policy on the website. Councilor Fennessy noted that within that policy it references that an annual review of department policies takes place, inquiring as to when that review was to take place, as well as whether or not Chief Osgood anticipated any changes as a result of the review. Chief Osgood responded, indicating the annual review was recently completed and was being compiled now.

Councilor Fennessy inquired as to whether or not Chief Osgood anticipated they would be posting other departmental policies on the web. Chief Osgood indicated

he and the City Solicitor had been discussing that issue and would be looking at individual policies and making access available, when appropriate.

Councilor Hatfield asked Councilor Grady Sexton if she could speak briefly about the upcoming Public Safety Board meeting.

Councilor Grady Sexton, Chair of the Public Safety Board, indicated the next meeting was June 29, 2020 at 3:00 p.m., at which time the committee would be reviewing annual reports from both the Police and Fire Departments. Councilor Grady Sexton indicated that also on the agenda is a review of the Use of Force policy, with the hope to break down the policy and answer the eight questions constituents are asking from the "8 can't wait policy" campaign. Councilor Grady Sexton indicated that Chief Osgood and Solicitor Kennedy would be in attendance to provide a very thorough overview of the current policies and any potential changes.

Councilor Hatfield inquired as to whether or not the Public Safety Board meeting would be an electronic, Zoom meeting. Councilor Grady Sexton indicated that it would be, noting that information about the meeting would be posted on the City's website.

Councilor Hatfield inquired about the information Councilor Pierce had requested specific to unpaid parking citations that members of City Council received from Matt Walsh. Councilor Hatfield asked for clarification of information within the report, asking if what was reflected was five years of unpaid parking citations that totaled \$782,933. Mr. Walsh indicated the report went back five years and was through May 25, 2020, confirming the total outstanding amount in unpaid parking citations to be \$782,993.

Councilor Hatfield referred to suggested changes brought forward by Councilor Pierce asking if those changes were going to be considered by staff and/or City Administration.

Councilor Pierce indicated that he was hoping to work with the Parking Committee

on this issue, noting that he would be attending the next Parking Committee meeting to present his suggestions as to how some unpaid fines might be collected.

Councilor Champlin indicated that the Parking Committee meetings were public, stating that he looked forward to having Councilor Pierce bringing his ideas forward.

Councilor Kenison referenced collection letters sent out by the Parking Division within the Police Department every 45 days to vehicle owners, inquiring as to how long a period of time letters were sent out, as well as what the cost of postage and staff time was per letter. Mayor Bouley indicated that he believed between 11 and 12 reminders were sent out per ticket.

Mayor Bouley asked City Administration to reconsider the closure of all pools within the City by doing their best to try to open up at least a few pools this summer.

Councilors Nyhan, Keach and Fennessy spoke in support of opening some pools within the City this year, noting that there is much community interest in the pools opening for some portion of the summer season.

Councilor Todd supported a second look at the possibility of opening some pools for the summer. Councilor Todd also noted, for the record, that he has received many comments very supportive of the Concord Police Department.

Councilor Bouchard spoke in strong support of opening some of the pools for the summer.

8. Resolution for the annual capital closeout and repurposing of capital project funds; together with report from the Senior Accountant.

Action: Public testimony for this item was taken with item #7.

9. Resolution authorizing and appropriating for Fiscal Year 2021 (July 1, 2020 through June 30, 2021) the sum of \$9,866,500 for Capital Projects and authorizing the issuance of bonds and notes in the amount of \$6,813,000 for various Capital Projects more specifically identified in the budget document.

Action: Public testimony for this item was taken with item #7.

Action: Public testimony for this item was taken with item #7.

Public Hearing Action

11A. Resolution fixing and determining the amount of money to be appropriated by the City of Concord for the Fiscal Year 2021, ending June 30, 2021, for the General Fund, Special Revenue Funds, Enterprise Funds, Debt Service Funds and Diminimis Accounts.

Action: Prior to entertaining a motion on this item, Mayor Bouley noted that Councilor Grady Sexton, Councilor Kretovic and Mayor Bouley were taking Rule 6A, specific to the Crisis Center of New Hampshire. Mayor Bouley noted that Councilor Champlin was taking Rule 6A on the Greater Concord Chamber of Commerce.

Councilor Nyhan moved approval of this resolution. It was duly seconded by Councilor Kretovic. Prior to taking a vote, Mayor Bouley reminded members of City Council of the amendment made at the last Finance Committee Meeting. The amendment increased the general overhead expense program for the Concord TV section of the budget by \$57,110 and increased the general overhead revenue budget for cable TV franchise fees by \$57,110. Mayor Bouley asked for a motion to amend the resolution before Council to reflect that tentative vote.

Councilor Champlin moved to amend the resolution before Council to reflect the increase in the general overhead expense program for Concord TV, as well as increase the general revenue budget for Cable TV Franchise fees for the same amount, \$57,110. The motion was duly seconded by Councilor Bouchard and passed unanimously with a roll call vote.

Councilor Bouchard moved approval of the item, as amended. The motion was duly seconded and passed unanimously with a roll call vote.

Closing Remarks

Mayor Bouley thanked City Manager Aspell, Deputy City Manager Lebrun, as well as all of the municipal employees involved in the budget process this year. Mayor Bouley indicated that he saw the FY 2021 budget as more of a working budget that Council, acting as the Finance Committee, would likely be revisiting throughout the upcoming fiscal year. Mayor Bouley thanked members of City Council for all of the time they put into the budget process as well.

Specific to the City's Pay-As-You-Throw (PAYT) purple bag program, Mayor Bouley reminded all that, on April 20, 2020, due to the COVID-19 pandemic, City Council voted to suspend the program indicating that in line with that action and the Governor's stay at home order expiring June 15, 2020, he would like to reinstitute the PAYT program, effective Monday, June 22, 2020. Mayor Bouley indicated that suspending the program cost the City approximately \$136,520 per month, with an overall cost of approximately \$273,000, for the City to suspend the program from April 20th through the proposed reinstatement date of June 22nd.

Councilor Kenison inquired as to how residents would be notified of the reinstatement of the program. Mayor Bouley indicated residents would be notified about the reinstated program just like they were when the program was suspended, via social media platforms and press releases. City Manager Aspell agreed with Mayor Bouley's comments as to how residents would find out about the reinstatement of the program. Mr. Aspell indicated there would be no grace period.

Councilor Keach thanked his fellow Councilors on a great job done reviewing the FY 2021 budget, stating that he felt next year would be a very difficult budget year.

Councilor Rice Hawkins inquired as to whether or not there was a program available to assist residents that may not be able to afford to purchase the PAYT bags. City Manager Aspell indicated that residents could contact the City's Human Services Department to see if they qualified for assistance.

Councilors Hatfield, Werner, Pierce and Champlin spoke in support of reinstating the program.

Councilor Kretovic thanked those residents that continued to use the purple PAYT bags during the suspension of the program.

Councilor Kenison voiced her concern for residents that may not have access to social media, inquiring as to whether or not trash would be picked up at those houses where residents didn't hear about the reinstatement of the program. City Manager Aspell indicated residents not using the purple PAYT bags would not have their trashed picked up, they would instead receive a tag on their bags indicating they should be using the PAYT bags again.

Action: There being no further discussion regarding the reinstatement of the City's PAYT purple bag program, Councilor Champlin moved to reinstitute the City's PAYT program effective Monday, June 22, 2020. The motion was duly seconded by Councilor Kretovic and passed unanimously with a roll call vote.

Councilor Rice Hawkins addressed Council, speaking in support of City Council, as a group, making a formal statement condemning racism and police brutality. Councilor Rice Hawkins referred to an all Council email she sent last week, which indicated she would be pursuing a statement. An email sent just prior to tonight's meeting contains the proposed statement she would like Council to either edit and approve this evening, or meet on a date to be determined, to discuss and formalize.

Councilor Rice Hawkins further stated that her original intent was to propose a non-public discussion to work out the language of a potential statement, noting she had been informed that any potential discussion about a proposed statement should take place in public session.

Councilor Rice Hawkins indicated she would be happy to edit and pass a statement tonight, or to make a motion suggesting Council meet at another date and time to formalize a statement from the Council as a whole. Councilor Rice Hawkins stated it was important that everyone support a statement in a strong show of unity and opposition to problems that have faced our nation for far too long.

Councilor Rice Hawkins then noted that any comments she received from her fellow Councilors in response to her email to all last week had been incorporated into the proposed statement she would be reading this evening, restating her hope that Council formalize a statement from the Council as a whole.

Proposed statement read into the record by Councilor Rice Hawkins:

Concord stands together against racism and police brutality. As Mayor and City Councilors, we condemn the senseless deaths of Black Americans at the hands of police officers who violated their oaths to protect and serve, and we stand with people and communities across the country who are demanding a renewed focus on racial equity.

We pledge to use our platform, our voices, and our policies to combat racism and inequality, to listen to the experiences of community members most impacted, and to reflect on our own roles in how to address these challenges as we shape our path forward together.

Every person in our community deserves to be able to count on fair and just treatment, especially within the leadership and institutions of our democracy. Our nation's long and harmful history of systematic racism and institutionalized discrimination requires all of us to work harder to actively address and challenge racism and bias.

Over the coming months, Concord plans to convene community discussions and identify action steps to ensure that we are delivering on our commitment to racial justice. Our city is also undertaking a public review of our policing and use of force practices so that community members may feel confident in our approach. The Concord Police Department has a longstanding commitment to community policing, outreach to communities of color, and measured use of force; it makes sense in these moments to engage in a public conversation about those policies and programs and identify any areas for improvement.

Concord strives to be a diverse, inclusive, and welcoming community, and our

commitment and examination of how policies impact people of color in our community is important and can only further benefit all the residents of our city.

Mayor Bouley indicated that he had asked Councilor Rice Hawkins to bring this forward this evening in follow-up to her initial request to discuss this in non-public session.

Councilor Rice Hawkins moved to schedule a meeting to discuss and finalize a statement from the City Council, as a whole, condemning racism and police brutality. The motion was duly seconded by Councilor Hatfield.

Councilor Keach spoke in opposition to City Council speaking out as a body, rather in support of members of City Council speaking out with their individual opinions.

Councilors Werner, Champlin, Kretovic, Matson, Kenison, Todd and Mayor Bouley spoke in support of a formal statement, by City Council as a whole, on this national issue, while acknowledging how much has been done in the community to date.

Councilors Kretovic and Matson spoke in support of all of the progress the Police Department has made over the past several years in working to eliminate racism.

Councilor Nyhan moved to table this discussion for further discussion, pending the work of the Public Safety Board, which is meeting at the end of the month, as well as to include the Police Department and other members of City staff in future discussions specific to this topic.

Councilor Grady Sexton indicated she had heard from all members of City Council that all have a deep personal commitment to advance racial justice within the City of Concord further stating that she prefers to work on the statement as a whole including action items the City of Concord is willing to advance to ensure that we as a community are doing what is right.

Councilor Pierce agreed with Councilor Grady Sexton's comments, speaking in

support of tabling this discussion and working on a final statement together.

Councilor Fennessy thanked Councilor Rice Hawkins for taking the lead and drafting the statement that she recently sent to members of City Council, indicating he received it just prior to the meeting and hadn't had a chance to review it. Councilor Fennessy spoke in support of including action items in a final statement as stated by Council Grady Sexton.

Councilor Bouchard spoke in support of tabling this discussion and scheduling another meeting, sooner rather than later, to work on a potential statement as a group.

Mayor Bouley spoke in support of tabling the discussion and getting together again to finalize a statement, indicating that perhaps Council could get together and discuss next week.

Councilor Todd spoke in support of tabling the discussion and getting together, sooner rather than later, to finalize a statement from the whole City Council.

Councilor Rice Hawkins withdrew her motion to advance a statement this evening, in support of tabling the discussion and meeting next week to finalize a statement from all members of City Council. Councilor Hatfield withdrew her second to Councilor Rice Hawkins' initial motion.

Mayor Bouley indicated that since Councilor Rice Hawkins withdrew her motion, there was nothing before Council to table, suggesting that, instead the City Council meet next week to finalize a statement from the Council as a whole.

After brief Council discussion regarding a meeting date, Mayor Bouley suggested that Council meet Monday, June 22, 2020, at 5:30 p.m., after which Council would meet in non-public session regarding the City Manager's evaluation.
